1. Minutes and Attendance for the May 2010 meeting were approved.
2. Informational Items
  - a. President Rita Hauck welcomed Senators to a new year. All present introduced themselves. The 2010-2011 Faculty Meeting Schedule was distributed.
  - b. Board of Regents meeting
    - i. The Kansas Board of Regents has three new Regents: Ed McKechnie who was elected Vice-Chair, Mildred Edwards, and Tim Emert. The newly elected Chair is Gary Sherrer. The new President and CEO is Dr. Andy Tompkins. The Board of Regents revised seal has six stars on the bottom ring. (Attachment D)
  - c. COFSP meeting
    - i. In 2006-2007, the Council of Faculty Senate Presidents reported on the problems of recruitment and retention of faculty, with salary and workload being the top obstacles. Nothing much has changed since that time. Under Jeff Burnett's leadership as President of the Council, the Council requested the Kansas Board of Regents to advocate to increase compensation for faculty at nationally competitive rates, provide sufficient funding to recruit, rebuild faculty ranks to levels before the economic downturn, advocate for work-life balance policies, for improved access to non-salary forms of compensation, including professional development opportunities, and implement a uniform tuition waver policy for spouses/partners and dependants.   - d. President's Cabinet
    - i. At this month's President Cabinet, the University emergency plan was reviewed. Other agenda items included revised policies for cell phones, the campus posting on bulletin boards, kiosks and other areas, smoking, and budget. It looks right now that there will not be more cuts for higher education.

  - a. Melinda Wells, Interim Director of the Health Center, presented on changes for this year. A new smoking cessation program is underway. The new Health Center hours are 8 – 4:30 M-F. The Health Center is moving to electronic medical records. It is progressing but moving slowly. There is now electronic scheduling for appointments available. The Health Center can do allergy injections this year.
