Foreword

Graduate study leading to the master's degree was first offered at Fort Hays Kansas State College in 1929, and in 1958 the College was given permission to grant the Specialist in Education degree.

Prior to 1942 a thesis was required of all candidates for the Master's degree; but since that time some departments have allowed the student the option to choose a thesis, or to select additional course work. A research project of two to six hours of credits, is required of each student who completes requirements for the Specialist in Education degree. Copies of all theses and field studies are bound and deposited in Forsyth Library and are available on inter-library loan.

It is the hope that this publication will serve to inform the academic community, and the prospective graduate student in particular, of the range of research interest and opportunities in the graduate division at Fort Hays Kansas State College.
