1. Minutes and Attendance for the November 2010 meeting were approved.
2. Informational Items
  - a. System Council of Chief Academic Officers  
Numana (numanainc.com), a Kansas “grass roots” organization is working with Kansas universities on a goal to stamp out world hunger.
  - b. Council of Chief Academic Officers  
Reports included proposed admission standards and tiered funding.
  - c. Kansas Board of Regents  
Each university presented a sustainability report. Dr. Hammond presented our Sustainability Tracking Assessment and Rating System (STARS).
  - d. COFSP meeting  
Foresight 2020 and higher education’s impact in communities were topics discussed at the KBOR/COFSP breakfast.
  - e. President’s Cabinet
    - i. We did well on the Report on 2010 Regents Goals.
    - ii. Agnew Hall should be completed by fall 2012.
    - iii. The IPEDS report is out. This is a comparison with other similar institutions.
