The following request from Louis H. Banker, Treasurer, F.T.A., was . read:

the twenty now por be abolianed, "The Fort Hays State Chapter of F.T.A. requests that it be included in the list of those organizations which are recognized as approved by the college authorities.

"This organization is a national group affiliated with the N.E.A. and the K.S.T.A. Its purpose is to promote interest in the teaching profession and to afford professional experiences for students in this college who are interested in a teaching career. This organization holds a charter from the N.E.A. and is composed of approximately 60 members. (This is more than the number of members necessary to make it an honor chapter.)

"The club is sponsored by Dr. Naylor with Dr. Harbin serving in an advisory capacity and includes a number of the faculty as members.

"It is believed that this organization will be a credit to the collegiate institution and that its activities will afford favorable experiences for a better understanding of and preparation for teaching by its members."

This request was discussed.

RECOMMENDATION: It was recommended by the Faculty Senate that the F.T.A. be approved as requested. Seconded and carried.

Report of AACTE Committee V, Curriculum--Instructional Patterns.

The AACTE committee studying curriculum has made a report which was referred to the Faculty Senate. This report incorporates the report from the faculty committee appointed by the president after the February faculty meeting.

The Senate recommends for faculty consideration the following:

- 1. In the main the general education program is satisfactory.
- 2. A student's enrollment in general education courses be limited to not more than ten (10) hours in any one semester, excluding physical education, and including not more than one of the five (5) hour courses.
- 3. A student may be excused from a specific general education requirement by satisfactorily passing an achievement test covering that course. A student, with the consent of his major adviser, may be excused from the specific general education course requirement which is offered in that particular subject field.
- 4. That the forty hour major be abolished.
- 5. That the twenty hour minor be abolished.
- 6. That each subject field announce its thirty hour major in the catalogue.
- 7. That any course which is required on a major be offered at least every other regular school year, or, if it is not offered, a substitute course be provided.
- 8. That the advisers, especially the major advisers, be encouraged to advise prospective teachers to prepare in more than one field.
- That a study be made of the course numbering system of the college at an early date.
- 10. As soon as a student, who desires to become a secondary teacher, makes an application for directed teaching there should be a continued exchange of information between the major adviser and the director of secondary education for a more intelligent advisement of a prospective teacher.

The meeting adjourned at 5:30 p.m.
