FACULTY MEETING

May 19, 1953

Dean McCartney presented the recommendation of the Faculty Senate, under date of May 7 regarding the statement concerning the B. S. degree. Motion was made by Dr. Zinszer that this recommendation be approved. Seconded by Dr. Thompson and carried.

The next recommendation of the Faculty Senate was under date of May 11, in connection with the Honors Convocation. This recommendation is in three parts. Motion was made by Dr. Welty, seconded by Mrs. Simons, that parts 1 and 3 be approved. Motion carried.

The recommendation of the Faculty Senate concerning credit hours for directed teaching was presented. Motion was made by Dr. Welty, seconded by Dr. Harbin that the recommendation be approved.

The recommendation of the Faculty Senate, April 30, concerning the scheduling of activities was presented. Motion was made by Mr. Almquist, seconded by Dr. Thompson, that this recommendation be approved.

Dr. Herndon requested that the ballots given out at the beginning of the meeting be checked and handed in as the meeting adjourned.

Mr. Start called attention to the fact that there was a motion before the house when the meeting adjourned on April 28; i.e., a motion was passed to substitute, but the substitute motion was not voted upon. This matter had to do with the statements concerning the objectives of the college.

There was discussion of the statement of the AACTE Committee No. 1, and attention was called to some mis-statements therein concerning offerings. There seemed, also, to be some misunderstanding as to the final statement prepared by the committee.

Mr. Almquist moved to amend the motion by the addition of the statement that the AACTE Committee No. 1 be requested to revise the statement and distribute again to the faculty members so they could study it before arriving at a final decision. Motion was seconded by Dr. Harbin.

Mr. Start commented that it was the intent of Mr. Almquist's motion to re-commit rather than to amend the motion.

Motion to amend as presented by Mr. Almquist was voted upon and carried.

The chairman called for a vote upon the motion as amended. Motion carried.
