The meeting was called to order by the chairman, E. R. McCartney,  
and the new members, Dr. Harbin, Dr. Nutt and Dr. Tomanek, were welcomed  
to the Senate.

The chairman called attention to an article, A Reappraisal of  
the Philosophy and Purposes of Higher Education, which appears in the  
July, 1953, Educational Record.

#### Inter-Varsity Christian Fellowship Organization--

The Inter-Varsity Christian Fellowship group presented a request  
to the Faculty Senate last spring asking to be approved as a recognized  
college organization and that it would not give activity credit. In the  
April 17, 1953, meeting the Faculty Senate approved this request and it  
was presented to the Faculty in the meeting of April 28. The Faculty  
action was that "this matter be re-submitted to the Faculty Senate."

The Inter-Varsity Christian Fellowship group has set up meet-  
ings for the present school year. Miss Perkins has been meeting with  
the group. Dean McCartney talked with her about the group and its activi-  
ties. She said that the group seemed to need this organization. She also  
said that this need might be filled by membership in the Y.M.C.A. and  
Y.W.C.A. It was suggested that there is a need for religious expression  
and that the church-related colleges supply space, etc., for this type  
of group. Since many of our students come to Fort Hays because it is  
closer than a church-related college the opportunity for such expression  
probably should be supplied.

It was suggested that a committee survey the whole situation and present suggestions. This committee should report on the needs filled by the present religious organizations, type of meetings which are held, etc.

RECOMMENDATION: It was recommended that a committee be appointed to survey this situation and report to the Senate. It was suggested that the committee should study the record of the religious organizations and report on what they do, etc. Seconded and carried.

The following committee was appointed: Mr. Dalton, Chairman; Dr. Albertson, Dr. Choguill, Miss Garner, Dr. Hamilton, Miss McCarroll, Miss Perkins, and Mr. Start.

Summer Session--

In the Faculty Meeting on Tuesday, September 15, the faculty was asked their preference about starting classes at 7:00 a.m., and at 7:30 a.m.

Dean McCartney asked the Senate for their opinions regarding:

1. Classes beginning at 7:00 a.m., 7:30 a.m., 8:00 a.m.
2. Counseling on Tuesday, enrollment on Wednesday and classes beginning on Thursday.

These questions were discussed. The pre-summer session was also discussed. The enrollments in the pre-summer sessions have been decreasing and it may be that such a session is no longer needed. This session provided opportunity for teachers of eight-months schools to earn five credit hours previous to the summer session. Many of the students have completed most of the required courses as well as the low-numbered courses and it is difficult to provide a satisfactory schedule of classes. The Saturday classes make it possible for students to enroll for courses during the school year and this probably decreases the need for the pre-summer session.

RECOMMENDATION: It was recommended that the pre-summer session be discontinued immediately. Seconded and carried.

The meeting adjourned at 5:10 p.m.
