Minutes of the meeting of the Faculty Senate, Tuesday, June 9, 1964 at 3:30 p.m. in the Office of the Dean of the Faculty.

The meeting was called to order by the chairman, Dr. Garwood. Copies of Application for five new courses were sent to the Senate members before the meeting.

New Courses: Dr. Garwood said that the Language, Literature and Speech Division requested approval of two new courses, Daily Elementary Latin 10, 5 cr. hrs. and Daily Elementary Latin 11, 5 cr. hrs. The description of the courses are as follows:

10 Daily Elementary Latin, 5 credit hours. No prerequisite. An introductory course in the basic elements and structure of the Latin language.

11 Daily Elementary Latin, 5 credit hours. Prerequisite, Latin 10 or equivalent. Continuation of course 10.

Mr. Rematore was asked to explain the need for the course. He said that by offering two-5 hour Latin courses instead of three-3 hour courses this would enable the student to complete his Latin requirements in two semesters instead of three. This would aid him in working out his schedule and at the same time take care of the same number of people in two semesters instead of three semesters. Elementary Latin 1, 3 hrs. cr.; Elementary Latin 2, 3 hrs. cr.; and Intermediate Latin 23, are to be dropped from the course offerings.

It was asked if the new courses which total 10 hours would require 10 hours of work compared with the 9 hours of work required in the past. Mr. Rematore said that the new courses would equal the same amount of knowledge learned by the student in the three-3 hour courses.

RECOMMENDATION: Dr. Bartholomew moved that the courses Daily Elementary Latin 10 and Daily Elementary Latin 11 be approved. Seconded and carried.

The request for the course, Campus Station Operation 52, one credit hour was presented. The description of the course is as follows:

52. Campus Station Operation, 1 cr. hr. Prerequisite, 16 and 21. Students staff ~~and~~ operate the campus radio station for the purpose of applying previously learned radio techniques. Current events in broadcasting are discussed with special consideration devoted to the problems of programming and management. Course may be taken a total of four semesters.

Mr. Heather was asked to explain the need for the course. He said that this would provide opportunity to give students the experience they needed when confronted with problems after they are employed as radio and TV announcers. In other words, they would practice what they have learned. Only juniors or seniors would take the course.

RECOMMENDATION: It was moved that the course 52 Campus Station Operation be approved. Seconded and carried.

RECOMMENDATION:
Dr. Staven moved that the course Campus Station Operation 52 be offered this school year. Seconded and carried.

Dr. Garwood suggested the remaining two courses to be approved would be taken up at the next meeting.

The meeting adjourned at 4:50 p.m.
