The meeting was called to order by the chairman, Dr. Garwood.

Petition of the Prometheans Club was presented to the Senate. This petition was accompanied by the constitution, names of the officers, and the membership. The request was considered by the Senate and discussed as follows:

It was asked if this group intended to seek affiliation with a national fraternity. Overtures have been made to a national fraternity.

It was asked if the membership of this group consists of students who have been members of a fraternity on this campus.

The reaction of the Interfraternal Council to the organization on the campus was discussed.

The events in which the group has participated were mentioned.

The financial backing was discussed. It was brought out that the Constitution submitted was not in its final form. It was felt that additional information was needed and that approval on the application be deferred.

RECOMMENDATION: Mr. Coulson moved to table this request. Seconded and carried.

94. Application for a new course--94. Workshop (Home Economics.) ^{*Title*} The application for this workshop was presented. The description is as follows: Three credit hours. Prerequisite, 47 or permission. Tailoring techniques with construction of a coat or suit required. Emphasis on design, fabric and fitting. Other construction techniques as requested.

This workshop was discussed.

RECOMMENDATION: Mr. McKee recommended that the Workshop 94 ^{*3 cr hrs.*} be approved. Seconded and carried.

It was announced that the Faculty Senate would meet on Tuesday, January 15, but would not meet January 22 and 29 since those are the final
