Minutes of the Meeting of the Faculty Senate, Tuesday, February 7, 1967 at 3:30 p.m. in the Office of the Dean of the Faculty.

Members present: Dr. Coder, Miss Cotham, Mr. Dalton, Dr. Fleharty, Mr. S. Johnson, Mr. McGinnis, Dr. McMechan, Mr. Schmidt, Dr. Wilkins, and Dr. Garwood, Chairman.

Others present: Mr. Heil, Mr. Maxwell, Dr. Price, Mr. Twaragowski.

Members absent: Mr. Crites, Miss Gangwer, Mr. Tomlinson, Dr. Youmans.

The meeting was called to order by the chairman, Dr. Garwood.

Assembly. A request from the All Student Council, Sociology Club, United Christian Fellowship and Union Forums Committee was read. An assembly is proposed for Thursday, April 20, 1967 in which Dr. Lester Kirkendall would speak on "The New Morality and Interpersonal Relations." In addition to the details given in the request, Mr. Twaragowski provided further information. He said that Dr. Kirkendall was to be on the campus two days, Wednesday and Thursday, April 19 and 20. This was discussed. It was asked if a night convocation might be better. There is to be an evening convocation scheduled Wednesday, April 19. Dr. Garwood gave a report on the number of classes and laboratories scheduled at the 3:30 period.

RECOMMENDATION: It was recommended that the assembly be handled in the same way as the last assembly; i. e., that it be scheduled at 3:30 p.m. and that classes should not be dismissed but instructors have the option to dismiss the classes for the assembly. Seconded and carried.

Corrections to Schedule of Classes. At the last meeting of the Senate, it was suggested that a complete schedule of classes should be printed for the second semester in place of using the mimeographed pages showing the corrections. It was stated that these pages are cumbersome and difficult to use. Dr. Garwood reported that he had a reply from Mr. Tow regarding his request for information regarding printing the spring schedule of classes. The report was read to the Senate. Perhaps one of the main problems with this would be the question of time. If the pre-enrollment is to be held in December, it would be necessary to have the schedule ready for the printer two weeks previous to this and in order to do this the corrections would have to be assembled and the copy prepared previous to that. It was noted that this would be quite helpful prior to the enrollment but would probably have additional corrections in January.

It was suggested that the corrections for the pre-enrollment might be mimeographed and then prepare the corrected schedule for distribution about two weeks before enrollment.

Report. Mr. Dalton presented a report regarding the students in showing the number enrolled as freshmen, dropouts, etc. in the class of 1966. He explained how he gathered the material for the report. The report will be submitted for the Faculty Bulletin.

Cheating. The Faculty Handbook is being revised. Attention was called to the section on Cheating in the present handbook. It was noted that most colleges do not have anything about cheating in their catalogs. The method of handling cases of cheating was discussed. It was asked if the statements in the Handbook should be changed and made more specific. The discussion on cheating will be continued at the next meeting.

The meeting adjourned at 4:30 p. m.
