Discussion: SUBSTITUTION OF CREDIT IN MARCHING BAND FOR CREDIT IN P.E. *Sent to Pres. office 5-18-70*

~~RECOMMENDATION:~~ Dr. Miller moved that participation in Marching Band constitutes the fulfillment of requirements in P.E. for a maximum of 2 semesters. Motion seconded by Mr. McCullick.

Discussion ensued. (See Minutes for details.)

The question was called for. The motion carried.

Discussion: CHANGE IN CLASS SCHEDULE.

Last fall, the Senate established a regulation that 3 weeks' notice be provided faculty members before changing the time schedule for any particular day. Dr. Sackett noted that Student Peace Coalition may be requesting a change in the time schedule for Thursday, May 14.

RECOMMENDATION: Dr. Sackett moved that the Faculty Senate waive the requirement of 3 weeks' notice.

The motion died for lack of a second.

Discussion: TEACHER SANCTIONS. (KSTA had imposed sanctions on the State of Kansas, etc.)

The meeting was called to order by Dr. Garwood, Chairman.

SUBSTITUTION OF CREDIT IN MARCHING BAND FOR CREDIT IN P.E.

RECOMMENDATION: Dr. Miller moved that participation in Marching Band constitutes the fulfillment of requirements in P.E. for a maximum of 2 semesters. Motion seconded by Mr. McCullick.

The Student Council has allocated \$2500.00 to the Marching Band for the fall of 1970. There will be approximately 130 students in the Marching Band. The \$2500.00 will be distributed to 50 upper division students. The Music Department is requesting that in the fall semester credit in Marching Band be substituted for credit in P.E. Participation in Marching Band would not give P.E. credit but the credit would be substituted for P.E. credit for a maximum of 2 semesters of P.E. credit.

Mr. McConnell stated that the Department of Health, Physical Education and Recreation would oppose the proposal on the matter of principle, i.e., they did

not believe Marching Band credit should be substituted for credit in P. E.

P. E. courses have carryover value for recreational activities after the student leaves school. Marching Band credit does not have this virtue.

Would it be possible to meet the requirements in Introduction to Music with credit in Social Dance or Square Dancing?

If it is desired to have a Marching Band, perhaps money should be made available for it. Is it a good policy to continue the Marching Band at the expense of some other Department?

If 2 hours of credit are permitted as the proposal indicates, would this solve the problem of getting students to participate in Marching Band?

The activities of the Marching Band are for the entire College and not just for the P. E. Department.

The Marching Band requires a considerable amount of the student's time. If students are to be in the Marching Band, they need recognition of some kind. If money were available, it would appear that students who are in the Marching Band should be compensated for this time. Dr. Miller stated that the Marching Band could not continue without additional aid from the College.

The question was called for. The motion carried.

#### CHANGE IN CLASS SCHEDULE

Last fall the Senate established a regulation that 3 weeks' notice be provided faculty members before changing the time schedule for any particular day. May 14. He moved that the Faculty Senate waive the requirement of 3 weeks' notice.

The motion died for lack of a second.

TEACHER SANCTIONS. Dr. Oliva asked for the College position on sanctions.

Dean Garwood said that Kansas State Teachers Association had imposed sanctions on the State of Kansas. The teachers of Hays High School have also called for sanctions. The College Placement Bureau makes this information available to all candidates who use the Placement service. Each candidate must use his own judgment.

It is conceivable that the Board of Education for the Hays Public Schools will arrive at an arrangement which will permit our student teachers to do their student teaching in the Hays Public Schools.

The meeting adjourned at 4:20 p. m.
