Minutes of the Fort Hays State University
Faculty Senate
June 5, 1995

A. President Dianna Koerner called the meeting of the Faculty Senate to order in the Pioneer Lounge Room of the Memorial Union on June 5, 1995 at 3:34 p.m.

B. C. The minutes of the May 2, 1995 were corrected. On page 4, University Affairs, Motion 1 should read The Faculty Senate recommends approval of the following name change for the Program Discontinuance Policy to "Policies and Procedures for Discontinuance of Undergraduate Programs" and that the last sentence in paragraph D3 be deleted. Minutes were approved as corrected.

D. For the Good of the University: President Edward Hammond addressed the faculty about the university's budget for 1995-96.

E. Announcements

2. The following information is from the minutes of the Council of Deans meeting on April 18. The Deans opposed the recommendation from Faculty Senate to add a signature line to the course change approval form. Maintenance of the curriculum is the responsibility of the Office of the Provost. Therefore, the recommendation will not be approved by Vice-Provost James Forsythe.

Vice-Provost Forsythe suggested that the Faculty Senate Academic Affairs Committee review changes in departmental curriculum. At present departments make changes at the time when the University Catalog is revised and no one reviews these changes.

3. Members of the design team for the ITV and Mediated Classrooms in Tomanek Hall include: Jim Vequist, Ron Hart, Connie Batten, Stephen Schleicher, Lou Caplan, Roger Pruitt, Jim Hohman, and Ken Neuhauser.

4. New faculty orientation is scheduled for August 14-16.

5. Provost Rodolfo Arevalo has been appointed to a community college and regents university committee to review the state-wide transfer and articulation agreement. Issues to be looked at include: differing tuition rates, delivery of upper division courses by community colleges, quality and preparedness of community college faculty, and the factors impacting the cost of education at community colleges and regents' universities.

6. The Council of Chief Academic Officers for the Board of Regents is strongly supporting a system-wide library proposal.

7. President Koerner has received from Dean Larry Gould an interim report on the design and implementation of the new general education program for Fort Hays State University. Interested individuals may contact President Koerner if they would like to see the report.

a. Motion 1: The Faculty Senate recommends approval of the following course for inclusion in the General Education Program as an integrative course (results of the committee voting follow the course title) (attachment A).

INTS 402 U.S. Human Geography: Issues for the 21st Century (7-0-0)

b. Motion 2: The Faculty Senate recommends approval of the Proposed Program and Curriculum for the Department of Technology Studies (attachment B - part of the proposal, however, the entire document was reviewed by Academic Affairs and approved 7-0-0).

Dr. Fred Ruda, Chair, Technology Studies, explained the reason for the changes. Attachment B also described the history of the proposed changes.

Motion passed.


Amigos is moving along. The committee is also looking at the updating of equipment in the library.
