0018 AN ACT making and concerning appropriations for the fiscal  
0019 years ending June 30, 1986, June 30, 1987, June 30, 1988, June  
0020 30, 1989, and June 30, 1990, to initiate and complete certain  
0021 capital improvement projects for Kansas state university,  
0022 Pittsburg state university, university of Kansas ~~and~~, Wichita  
0023 state university *and Fort Hays state university*; authorizing  
0024 certain transfers, imposing certain restrictions and limitations,  
0025 and directing or authorizing disbursements and acts incident-  
0026 tal to the foregoing; amending section 3 of chapter 27 of the  
0027 1985 Session Laws of Kansas and repealing the existing sec-  
0028 tion.

0029 *Be it enacted by the Legislature of the State of Kansas:*

0032 ations are hereby made, restrictions and limitations are hereby  
0033 imposed, and transfers, disbursements and acts incidental to the  
0034 foregoing are hereby directed or authorized to initiate and com-  
0035 plete capital improvement projects as provided in this act.

0130 *Provided, That expenditures from the renovate Sheridan coli-*  
 0131 *seum — phase I account during fiscal years 1987 and 1988 shall*  
 0132 *be matched by expenditure of a total of \$500,000 from the*  
 0133 *Sheridan coliseum gift fund during such fiscal years.*

0134 *Renovate Sheridan coliseum — phase II*

0135 *For the fiscal year ending June 30, 1989 .....* \$1,500,000

0137 *For the fiscal year ending June 30, 1990 .....* 2,162,000

0139 *Provided, That expenditures from the renovate Sheridan coli-*  
 0140 *seum — phase II account may be made only upon certification*  
 0141 *by the director of accounts and reports that \$1,250,000 of pri-*  
 0142 *ate gift funds are available for expenditure for this project.*

0143 **Sec. 6 7.** On the effective date of this act, section 3 of chapter  
 0144 27 of the 1985 Session Laws of Kansas is hereby repealed.

0145 **Sec. 7 8.** This act shall take effect and be in force from and  
 0146 after its publication in the statute book.
