Faculty Meeting

March 19th, 1934

The faculty meeting was held in the library. The following persons were absent: Mrs. Cruise, Mr. Gross, Mr. Malloy, Miss McCarroll, Mr. Riley, Mr. Yeager, and Dr. Zinszer.

Dr. Rarick made a statement regarding the affairs of the institution and the need to organize detailed budgets for the coming year at an early date.

Dean Lee made a statement regarding the possibility of a change in the assembly period. This matter was left open to be taken up at another meeting.

Dean Lee also made a statement that there was an agreement that no classes should meet at the 11:00 hour on Tuesday morning. This hour being kept open for activities. Dr. Reed stated that there were no conflicts on Tuesday morning because of his psychology classes which meet at that hour. Attendance not being compulsory. The matter was left to the department and to Dean Lee to arrange.

Dean Lee reported the request for 6 weeks grades had not been responded to fully by the faculty. He then asked the wishes of the faculty in regard to 9 weeks grades. Motion was made by Dr. McGrath and seconded by Dr. McCartney that we continue the 6 weeks report. Motion lost. — ?

Mr. Parker moved that we report to the office the unsatisfactory work at the end of the 9 weeks not in terms of D's or F's. Seconded by Dr. Walker. Dr. Barton offered an amendment that a report be made at the end of 12 weeks in terms of grades. Amendment was seconded by Mr. Thompson. Amendment defeated. Vote was taken on the original motion and was carried.

Motion was made by Mr. Rankin that Monday be added to the Easter period. Seconded by Dean Agnew. After some discussion Mr. Hobart Davis offered a suggestion motion that Easter vacation begin at noon on Friday and

close at noon on Monday. Seconded by Dean Lee. Suggestion motion lost. Dean Lee offered an amendment that the vacation close Monday noon. Amendment seconded and lost. Motion was made by Mr. Thompson that the Easter vacation be carried out as scheduled in the catalogue. Seconded by Mr. Parker and carried.

Meeting adjourned.
