The meeting was called to order by the chairman, Dr. McCartney, who presented the statement on Academic Probation.

Academic Probation: At the last meeting, it was suggested that the present statement on Academic Probation might be revised and rearranged. The method of reinstatement was included in the previous material and subheadings were added in an attempt to clarify the material for students. The revised copy was discussed. It was suggested that the paragraph on reinstatement should be rearranged to make it more understandable. Another suggestion was that a statement should be added explaining the procedure for determining the grade index as many students do not seem to understand how to do this. Another suggestion was that a copy of the transcript might be sent to the student with the notice of probationary status as well as a copy of the application for reinstatement. The introductory paragraph was discussed.

RECOMMENDATION: It was recommended that the introductory statement be removed.  
Seconded. FAILED TO CARRY.

It was suggested that the forms for Academic Probation and the Application for Reinstatement be revised and presented at the next meeting of the Senate.

Reading Services: Copies of a communication from Miss Groesbeck, Director of the Reading Services, were distributed to the Senate members. It was asked that members read these and bring them to the next meeting when the proposals would be discussed.
